1. **Rental Period:** The rental period between Hidden Dealz and the customer shall commence on the date agreed upon. Customer shall choose Monthly, Bi-weekly or Weekly payment.
2. **Payment:** The customer agrees to pay Hidden Dealz all amounts due and payable to Hidden Dealz under the Rental Agreement plus applicable taxes and fees, including, without limitation, to all furnishing ("the Rental Agreement") amounts and delivery charges indicated on the invoice and Rental Agreement. Payment is due on the effective date of the Rental Agreement.
3. **Payment Methods:** Hidden Dealz accepts payments by credit card (Visa, Mastercard), online payment through our website (www.hiddendealz.ca), E-transfer and PayPal, all payments are secured. The customer authorizes Hidden Dealz and its employees to charge or deposit all amounts due (plus applicable taxes) and payable to Hidden Dealz under the Rental Agreement.
4. **Ownership:** The customer acknowledges and agrees that the layaway items listed on the Rental Agreement are owned and rented by Hidden Dealz until the customer pays off the agreed amount in full on this said Rental Agreement. With no exception Hidden Dealz will not take back the item(s), this is final sale.
5. **Governing Law:** (i) The Rental Agreement is governed by the Laws of Ontario; and, (ii) the Rental Agreement constitutes the entire agreement between Hidden Dealz and Customer; there are no other agreements, written or oral; and the Rental Agreement shall not be altered or amended except by a written instrument signed by Hidden Dealz and Customer.
6. **Notices:** Any notice or other communication required or permitted to be given hereunder shall be in writing and shall be delivered in person, transmitted by email or other means of recorded electronic communication, or sent by courier or registered mail, charges prepaid.
